Focusing on Data: The COE Digital Community Scorecard and Toolkit

Whether you work in government, business, education, healthcare or non-profits—data is the cornerstone of informed decision-making and strategic planning. We all rely on data to make decisions that impact the organizations and the communities we serve. In the 2023-2024 Communities of Excellence Framework, questions about data appear in all seven categories and the Community Profile, though it is featured most prominently in Category 4: Measurement, Analysis, and Knowledge Management.

Accurate data provide a clear picture of our current reality, enabling leaders to identify trends, anticipate challenges, and seize opportunities. It can also help us build trust with our residents and other stakeholders, evaluate the success of our programs and services, and demonstrate impact.

Meaningful data facilitates collaboration among different sectors and organizations. When data is shared and accessible, it creates opportunities for partnerships and collective problem-solving.

When selecting metrics for an entire community, as the leaders in our National Learning Collaborative are doing, it is essential that they paint a picture of the interconnectedness of various factors affecting the community. By avoiding a narrow focus, leaders can develop more integrated and effective strategies that address the root causes of issues, avoid unintended consequences, and create sustainable solutions.

But how do we select metrics that represents our community, are inclusive, meaningful, accurate, and timely? This is the challenge we took on beginning in 2021 thanks to the support of the Robert Wood Johnson Foundation's Data Across Sectors for Health (DASH) Mentor Grant.


We knew that our community teams were struggling with how to best select, track, and communicate the data that is essential for moving from reactive to systems-thinking leadership. They were asking for a standard set of metrics, reliable resources of credible data, and help with messaging. While the Communities of Excellence Framework, based on the proven Baldrige Excellence Framework is a comprehensive system, it is not prescriptive. Providing a Common Community Scorecard Template and Data Communications Tools would be helpful to COE, too, as we continuously validate the effectiveness of our model.

Today, our initial scorecard of five interdependent, high-level metrics has expanded to include over 30 cascading metrics, detailed instructions to access the data, data visualization guidelines, and data literacy tools. In this newsletter you'll learn how we've recently digitalized this scorecard to make it even more accessible and customizable to communities across the country and hear how one community in central Minnesota plans to use it.



COMMUNITY PARTNER HIGHLIGHT Granite Table Focusing on Data to Empower the Greater St. Cloud Region

Intentions for using the COE scorecard? Yes!

Granite Table, the Central MN Communities of Excellence Alumni Cohort, has been talking more and more about data as a key priority to drive positive change in the Greater St. Cloud Region. As the local scorecard evolves, Granite Table partnered and contracted with St. Cloud State University and a community expert, to commission a mapping dashboard using an ArcGIS Hub platform. The Hub provides insights at the Census tract level across 6 cities and 27 tracts. The initial focus has been housing indicators to support prominent existing activities in the community.

A community scorecard aligns with the work of multiple Granite Table partners. One partner is the Central MN Alliance (CMA), which is a collaborative of three county public health agencies and the CentraCare Division responsible for community health improvement. CentraCare has been the Granite Table backbone and CMA has led the Health Sector work from cohort inception. The CMA prepares a community health improvement plan (CHIP) every three years and the current CHIP identifies a goal to increase data access to the threecounty region. The Greater St. Cloud Region lies in the heart of the three counties. All data for the Greater St. Cloud Region also applies to all three counties.

Version one of the Granite Table mapping Hub became available in May 2024. The CMA Data Committee and the Granite Table Data & Information Committee had their first joint meeting at the end of May and are in the process of analyzing what the maps are telling us about the community. The identified insights will be

shared with the community via the Granite Table website and through partner conversations.

The highly anticipated COE tabular and graphing scorecard, supported by the Tapp Network, providing additional COE cascading indicators and allowing a space to add local measures to support the community story, will complement the Granite Table ArcGIS Hub. The combination of spatial and tabular data will give Granite Table a 360-degree view of the region, empowering us and community partners to make more strategic, data-driven decisions. We are particularly looking forward to the subcommunities function, which will allow us to create subcommunities for the three counties and any other geographies that will support partners as we engage with conversations about the data.
